Sub: 2nd Phase of Rashtriya Karmayogi Large Scale Jan Seva Program - reg

In line with the Hon'ble Prime Minister's vision of fostering the Karmayogi mindset and Seva Bhava amongst Central Government employees, Capacity Building Commission (CBC) has launched Rashtriya Karmayogi Large Scale Jan Seva Program. In the first phase of the program, employees (up to Director grade) of Central Government Ministries/Departments were targeted, second phase program would take this training to each office of GoI across the country, whereby 1-day training is to be imparted. The basic training delivery model is as follows :

- Ministries/Departments to nominate officers for 5-day training as Lead Trainers by CBC.
- Lead Trainers in pair need to impart 3-day training at their resp. organization to the nominated officials as Karmayogi coaches in batches of 30-35 officials.
- Karmayogi coaches in pair need to impart 1-day training to officials of their resp. organisation in batches of 30-35 officials.

2. Indian Railways is actively participating in this initiative and for delivery of 2nd phase training on IR, faculty/officers nominated by CTIs, Zones & PUs have been nominated for 5-day training as Lead Trainers by the CBC.

2.1. Further delivery of the program has been considered and it has been decided to integrate the 1-day training in IR's existing training ecology and utilise extensive railway training facilities for delivery of the second phase of Large Scale Jan Seva Program in the following manner :

SN	Action	Timeline
1	Lead Trainers from CTIs may conduct 3-day training sessions (in adequate batches) at suitable venue for faculty from CTIs, MDZTIs, MDDTIs, STCs of zones and BTCs of PUs & Workshops to train them as Karmayogi Coaches. Personnel deptt of each Zonal railways/PUs will nominate their MDZTIs/MDDTIs/STCs/BTCs faculty for their training as Karmayogi Coaches as per training plan decided by CTIs.	To be completed by 30.06.2025
2	Lead Trainers from Zones/PUs may conduct 3-day training sessions (in adequate batches) at suitable venue for subordinate officials upto SS/JS level to train them as Karmayogi Coaches. Personnel deptt of the concerned railway administration will identify suitable officials for their training as Karmayogi Coaches.
