Sub: Standard of Inhibited Mineral Insulating Oil to be used in Transformers of Indian Railways.

RDSO vide their letter under reference (i) had communicated to this office that it has been decided to switch over of Transformer oil as per IS:335-2018 to Type-A Transformer oil as per IEC: 60296 for utilization in the Transformers of the Traction Sub-stations (i.e. Power Transformers Autotransformers Auxiliary Transformers Current Transformers and Potential Transformers) and also advised to intimate the vendors that are appearing in the CORE Vendor Directory for Inhibited Mineral Insulating oil as per IS: 335(Type-II) but are not appearing in the CLW Vendor Directory for oil as per IEC: 60296, to get themselves approved with CLW for the Insulating oil as per IEC: 60296. This decision shall be effective after six months from the date of issuance of RDSO letter Dt-29.04.2024.

Accordingly, all CORE approved/ under approval vendor of Inhibited Mineral Insulating Oil as per IS:335:2018 were advised to take necessary action to get them approved in CLW for item Type-A Transformer oil as per IEC: 60296 vide this office letter Dt-14.05.2024, 19.07.2024 & 22.10.2024 under ref. (ii) above and the cut off time already completed on dated 28.10.2024.

In this regard, all CORE approved vendors/ under approval vendors of Inhibited Mineral Insulating Oil IS:335:2018 are hereby intimated that CORE Vendor Directory for item 4200040 Inhibited Mineral Insulating oil as per IS: 335 (Type-II) has been discontinued.
