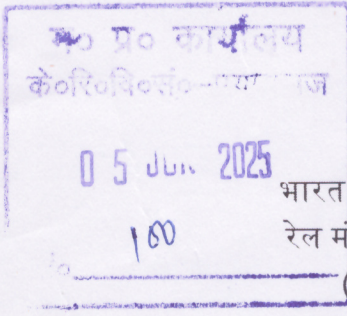

The Hon'ble Central Administrative Tribunal, Allahabad Bench, in its judgment dated 15.01.2025 in OA No. 378/2022, has directed the implementation of the merger of the Unit Purchase Cell (UPC) into the Ministerial cadre in accordance with the Railway Board's letter dated 26.10.2005 and subsequent reminders.

2. In compliance with the above, BLW, in consultation with the local staff union, has decided to merge the Unit Purchase Cadre with the respective Ministerial cadres (Stores/Non-UPC Ministerial cadre) with effect from 15.01.2025.

3. On the same lines, Railways/PUs where the UPC cadre is presently in existence are advised to take necessary action to merge their UPC cadre with the appropriate cadre. Any issues arising during the merger process may be resolved through mutual discussions with the concerned unions/staff representatives. Any legal directives may also be kept in view while deciding the subject.

4. In this regard, an Action Taken Report (ATR) may be furnished to the Board's office for information.
