



Ref:- FSSAI's letter File No. 1(42) 2011/Railway/FSSAI dated 24th April, 2015.

FSSAI vide their letter mentioned under reference above had notified that in terms of power vested under Sub-section (5) of Section 10 read with sub-section (3) of Section 30 of FSS Act, 2006 the Executive Director Health (G)/Indian Railways shall work as Additional Food Safety Commissioner and carry out all the functions and duties entrusted to the Commissioner of Food Safety except appointment of Designated Officers and Food Safety Officers under the Food Safety and Standards Act, 2006.

Dr. Namita Negi has been appointed as Executive Director Health (G) in Railway Board and in terms of FSSAI letter mentioned above she shall work as Ex-Officio Additional Food Safety Commissioner for the Indian Railways.
