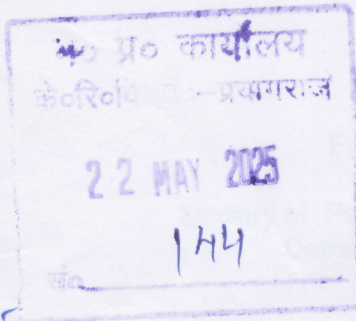

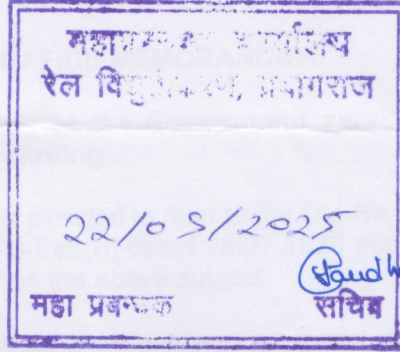


OFFICE MEMORANDUM
