



Subject: Verification of local content certificate through Unique Document Identification Number (UDIN System) -reg.


The undersigned is directed to refer to Para 9 of the Public Procurement (Preference to Make in India), Order 2017 dated 19.07.2024 which provides that "in cases of procurement for a value in excess of Rs. 10 crores, the 'Class-I local supplier'/ 'Class-II local supplier' shall be required to provide a certificate from the statutory auditor or cost auditor of the company (in the case of companies) or from a practicing cost accountant or practicing chartered accountant (in respect of suppliers other than companies) giving the percentage of local content ".

2. In this regard, all the Ministries/Department are requested to verify the authenticity of the certificate provided by the bidder, for purpose of faster verification of submitted certifications on local content through UDIN (a system generated unique number which is generated to verify the authenticity of documents attested/certified by these professionals) from the following links:
